(Revenue \$) FRIENDS OF THE CHILDREN-PORTLAND PROVIDES PORTLAND'S MOST AT-RISK CHILDREN WITH PROFESSIONAL, SALARIED MENTORS.WE TAKE A PREVENTATIVE,EARLY INTERVENTION APPROACH THAT BREAKS THE CYCLE OF POVERTY AND ABUSE BY HELPING CHILDREN IN NEED TO OVERCOME THE OBSTACLES IN THEIR LIVES. THE CHILDREN IN THE PROGRAM HAVE SIGNIFICANT CHALLENGES WITH 60% HAVING PARENTS THAT DID NOT COMPLETE HIGH SCHOOL, 50% HAVING ONE OR MORE PARENT THAT HAS BEEN INCARCERATED AND 85% BEING BORN BY A TEEN PARENT. THE CHILDREN OVERCOME THESE ODDS AS 91% REGULARLY ATTEND SCHOOL WITH AN 83% GRADUATION RATE, 98% AVOID TEEN PARENTING AND 93% AVOID INVOLVEMENT IN THE JUVENILE JUSTICE SYSTEM.
